## IPSWICH CITY PISTOL CLUB

### LOCAL RANGE RULES



1. These Rules and the SSAA (Qld.) Inc. State Range Standing Orders are to be adhered to at all times.
2. All shooters are to follow the instructions and directions of the Range Officer. Powers of the Range Officer concerning conduct on the range are **absolute**.
3. All licensed shooters must sign the Range Use Register correctly and legibly in front of the Range Officer before entering onto the range.
4. All unlicensed shooters and any person that is required to complete a 'Form33' must complete this form in front of the Range Officer before entering onto the range and must be supervised one-on-one by a licensed shooter.
5. Range facilities (posts, target hangers, lights etc.) **are not to be shot at**. Any person deliberately shooting the range facilities will be asked to leave the range. Any damage is to be reported immediately to the Range Officer.
6. All firearms must always be pointed down range. Cross firing on the range is strictly forbidden. Offenders may be asked to leave the range.
7. All firearm malfunctions are to be immediately reported to the Range Officer. This is to be indicated by activating your safety button in a short burst then switch off and wait for the Range Officer to attend to your malfunction. Only leave the buzzer on continuously in an emergency.
8. Hearing protection and eye protection must be worn on this indoor range.
9. Enclosed footwear is mandatory. Appropriate clothing as detailed in the State Range Standing Orders is to be worn.
10. Any person deemed by the Range Officer to be under the influence of alcohol or drugs will not be permitted on the range.
11. All Firearms are to be cleared by the Range Officer before the firearm leaves the firing line.
12. No person is permitted past the firing line at any time.
13. Only one firer is allowed in a firing bay at any one time.
14. No shooting in a kneeling position is permitted unless approved by the Range Officer.
15. Ammunition: Lead cast, lead cast copper wash and fragmenting projectiles are permitted. No military ammunition or full metal jacketed projectiles are to be used.
16. Only SSAA (Qld.) approved targets are to be used at a **minimum target distance of 7 metres**.
17. Fired cases are to be placed in the receptacles provided. Targets are to be taken with the shooter or placed in a bin.
18. All shooters should wash their hands in the basin provided prior to leaving the range.

## General Information

### Obtaining a Queensland Weapons Licence - Category H

#### STEP 1

##### Eligibility and Membership of approved pistol clubs

A person cannot apply for membership to an approved pistol club unless that person submits with their application for club membership the following information:

- Evidence of a current Firearms Licence;
- If you are not a licensee, you will need to provide a current "QP0515 Statement of Eligibility" issued by the Queensland Police Service (Weapons Licensing Branch). The document shows that you are a fit and proper person to hold a license. This statement is current for 3 months after the day it is signed by the Authorised Officer, Weapons Licensing Branch.

##### Procedure for obtaining Statement of Eligibility from the Queensland Police Service.

- Submit form "QP0515 Application for Statement of Eligibility" to join an Approved Pistol Shooting Club at your local police station. There are no fees applicable when submitting this application. A Statement or Notice will be sent to the applicant at the address provided on the application.

Once you have received your Statement of Notice from the Queensland Police Service, obtain two (2) character references, complete a Pistol Club Membership Application form and submit it in person with payment. You will also need to make a declaration that either you are a current member of another approved shooting club or that you are not a current member of any other approved shooting club

#### STEP 2

##### 6 Month Probation Period

During your probation period you are required to attend and participate in;

- A minimum of 3 handgun shooting competitions in the 6 month period prior to you applying for your license. You are encouraged to participate in more competitions, if possible;
- You are also required to complete a Course in Firearms Safety for Category H Firearms.

##### Procedure to follow before and on arrival at and whilst on the range at an approved pistol club

- Please phone and arrange or personally attend the range and notify staff that you wish to participate in a pistol competition. This is to ensure a Range Officer will be available to supervise your shoot. Whilst you are unlicensed during the probation period and when using a firearm you **must** be supervised by a Range Officer;
- You **must** pay range fees and sign the range register before you shoot;
- You **must** complete a Form 33 (Weapons Act Section 53) before you shoot;
- You **must** have photographic proof of identity every time you attend the range to shoot (**NO ID, NO SHOOT**);
- You **must** have your QP-516 Participation Card which is to be signed off at the completion of each competition and at the completion of the Safety Course;
- You **must** wear enclosed footwear and it is highly recommended to not wear loose clothing. Hot ejected cases will burn the skin;
- It is **strongly recommended** that as a condition of entry you wear eye and ear protection at all times whilst on the firing line or in close vicinity;
- You **must** follow all directions given by staff and Range Officers whilst on the range. Your safety and that of others on the range is of the highest importance.

## STEP 3

### Application for Concealable Firearms Licence (Qld Resident)

Once you have completed your 6 month probation period, the safety course and have completed the minimum required competition shoots, you may submit your application for a licence. This can either be done online or via your local Australia Post outlet. You will require:

#### Australia Post Licensing Process:

- A current declaration by the REPRESENTATIVE of the approved pistol club, stating the applicant has:
  - a. current financial membership with the club;
  - b. been a member of the pistol club for the 6 month period; and
  - c. completed in a least 3 competitions during the 6 months.
- A copy of your Statement of Attainment for the Course in Firearms Safety for Category H Firearms;
- Your completed Form 1 "Application for Licence";
- A copy of your QP-516 Pistol Club Shooters Participation Card (records your 3 or more competitions within the 6 month probation period);
- Provide identification for verification: Drivers Licence, Passport, Proof of Age Card- 15+ or 18+, Medicare Card, a named bill (e.g. rates, telephone, electricity), original Birth Certificate, Education Queensland Photo Identification.
- Two passport size photos are required
- Pay the prescribed Licencing fees.

#### Online Licensing Process:

- A current declaration by the REPRESENTATIVE of the approved pistol club, stating the applicant has:
  - a. current financial membership with the club;
  - b. been a member of the pistol club for the 6 month period; and
  - c. completed in a least 3 competitions during the 6 months.
- A copy of your Statement of Attainment for the Course in Firearms Safety for Category H Firearms;
- A copy of your QP-516 Pistol Club Shooters Participation Card (records your 3 or more competitions within the 6 month probation period);
- Pay the prescribed Licencing fees.

Following the submission of your online application – Weapons Licensing Branch will send you an e-mail requesting you present to a local Australia Post outlet to provide your identification for verification and also your passport photos. You will need to provide Australia Post with original documents only as they will not accept copies.

Note: When completing the application which asks for the genuine reason for obtaining a concealable firearms licence the reason should be "For target shooting on an approved range." It is illegal to use a concealable firearm for hunting purposes.

#### General Information

An individual licensee must not, during the first year after the individual is first issued with a concealable firearms licence, acquire for sports or target shooting under that licence more than:

- (a) 1 air pistol; and
- (b) 1 of the following—
  - a rim-fire pistol;
  - a centre-fire pistol;
  - a black-powder pistol.
